

County Service Delivery Survey 2019

Brief Introduction

CoRG – **Consortium of Researchers on Governance** is a professional association of several research firms bringing together more than Sixty (60) individual researchers, data analysts and communication experts, aiming to improve citizen's engagement in national and county governance.

CoRG conducted a self-funded survey between 21st January and 20th February 2019, to assess county governance and attendant performance of the devolved units as per their mandate envisioned in the Fourth Schedule of The Constitution of Kenya.

The study aggregates and ranks all the 47 Governors using the following Key Performance Indicators (KPIs);

- 1. Delivery of devolved government services
- 2. CIDP, budgeting and public participation
- 3. Governor's Job approval rating

Methodology

Due to the nature of the survey, Stratified Multi-stage sampling was adopted, with the Ward being the Primary Sampling Unit.

The Counties were amalgamated into 10 regions (Nairobi, Western, Nyanza, North Rift, South Rift, Central, Upper Eastern, Lower Eastern, North Eastern, Coast) and allocated to 10 teams, targeting adult Kenyans, 18yrs and above, living in urban, peri-urban and rural areas.

A total of 6,891 respondents were interviewed (Table below), the sample size having a 95% confidence level and a 5% margin of error.

Data Collection


The data was Quantitatively collected through Face-to-Face interviews using questionnaires, and Qualitatively through regional focus groups.

The interview language was English, Swahili and local dialect when necessary.

<u>Analysis</u>

Data collected was entered, cleaned and collated in MS Excel, and later exported and analyzed in SPSS.


Kenya Map showing Counties










1. Delivery of Devolved Government Services (as per the Fourth Schedule of **Constitution of Kenya 2010)**

Summary: CONCLUSION

- Majority of the population are not conversant with details of the Fourth Schedule Constitution of Kenya 2010, and therefore cannot differentiate between national and devolved services.
- Public participation on budget-making process is improving, but there is lack of followup.
- Many projects indicated in the CIDP as 'on-going' are either lagging or non-existent.
- Governor's job approval in some counties was irrational i.e not dependent on the Governor's performance but national politics.
